

REQUEST FOR PERMISSION TO REPRODUCE CALIFORNIA ASSOCIATION OF REALTORS® STANDARD REAL ESTATE FORMS

Real Estate Business Services, Inc. ("REBS") under authority from the California Association of REALTORS® ("C.A.R.") considers requests to license/reproduce C.A.R.'s copyrighted standard real estate forms ("C.A.R. Forms"). Inquiries regarding a license to use C.A.R. Forms should be directed to the Standard Forms Department at 213-739-8225 or juliej@car.org. In order to gain permission from REBS to reproduce C.A.R. Forms, You/Company must agree to the Terms and Conditions below and fill out the Reproduction Request Form on Page 3 of this document.

Terms and Conditions

You/Company agree that, if approved by REBS as noted on Page 3, your right to reproduce any Approved Forms is subject to and conditioned on the following:

1. REBS grants to You/Company, until the date these Terms and Conditions are terminated as provided herein, a non-exclusive, nontransferable, royalty-free, fully paid-up, worldwide license (the "License") to use, reproduce, and publish the Approved Forms in accordance with, conditioned upon and pursuant to the terms and limitations set forth in these Terms and Conditions.
2. The License granted to You/Company is a limited right to use, reproduce and publish the Approved Forms in the specific media approved by REBS in writing. In no event shall You/Company use the Approved Forms in any other medium or sell the Approved Forms in any other medium whether as a single form or a compilation of forms, even if the Approved Forms are labeled "SAMPLE". Your right to reproduce the Approved Forms is personal to You/Company and may not be assigned, transferred or sold.
3. Unless otherwise approved by REBS in writing, Approved Forms must be reproduced in their entirety with the word "SAMPLE" screened across the main body of text of each page of every Approved Form.
4. All electronic formats of the reproduced Approved Forms shall: (a) be an image of the form only, (b) be strictly limited to a non-interactive static image of the forms, (c) include reasonably adequate safeguards to prevent importation into other documents, reproduction and/or conversion of the Approved Forms to computerized programs, and (d) include such other protections and requirements as may be reasonably required by REBS.
5. All reproductions of the Approved Forms shall contain the following notice: "The following form is copyrighted by the California Association of REALTORS®, © [insert copyright date], and is reprinted under a limited license with permission. Photocopying or any other reproduction, whether electronic or otherwise, is strictly prohibited."
6. If REBS provides You/Company with material changes to the Approved Forms, You/Company shall incorporate such changes into your reproduction of the Approved Forms as soon as is commercially reasonable. REBS shall have no obligation to update any Approved Forms and/or to provide any such update(s) to You/Company.
7. The License is conditioned on compliance with all the Terms and Conditions, including, but not limited to, providing copyright notices, attributions, imaging and formatting reasonably designed to preclude unauthorized copying. You/Company agree to abide by the limitations of these Terms and Conditions. You/Company represent and warrant that You/Company will reproduce the Approved Forms only as approved by REBS and/or C.A.R. in writing. You/Company represent and warrant that the individual signing below for Company (if applicable) is duly authorized with legal authority to bind Company to these Terms and Conditions.
8. The content of the Approved Forms is based on the law of the State of California and Federal law. The Approved Forms do not take into consideration any individual local ordinances within California or any states' laws outside of the State of California. Further, the Approved Forms are designed for use by California real estate licensees and not for the public acting without a broker licensed by the California Bureau of Real Estate. By providing the Approved Forms, REBS is not representing or guaranteeing the

legal validity of a form for any specific transaction or a court's final interpretation of a form, or portion thereof, or whether the intended use and meaning of a form, or portion thereof, will be upheld. Users of the Approved Forms seeking legal interpretation and advice should seek independent legal counsel on such matters. You/Company acknowledge that the intended audience for the reproduced Approved Forms is licensed attorneys and real estate agents and brokers licensed by the California Bureau of Real Estate and not the general public. Notwithstanding the foregoing, You/Company make no representation or warranty as to who the ultimate purchaser or user of the reproduced Approved Forms (whether in hardcopy or electronic format) may be.

- 9. Prior to the distribution and/or display of any reproduction of the Approved Forms, You/Company must submit one sample of the same to REBS upon REBS' request.
- 10. Within thirty (30) days following your distribution and/or display of the reproduced Approved Forms, You/Company agree to provide REBS with one copy of any such reproduction.
- 11. REBS AND/OR C.A.R. MAY REVOKE YOUR RIGHT TO REPRODUCE THE APPROVED FORMS AT ANY TIME AND FOR ANY REASON. Your right to reproduce the Approved Forms shall begin on the Date of Approval noted on Page 3 (the "Date of Approval") and, unless terminated earlier by REBS and/or C.A.R.: automatically terminate on the one (1) year anniversary of the Date of Approval, or continue for a period of one (1) year, and thereafter automatically renew for successive periods of one (1) year each. Upon termination of your right to reproduce, You/Company agree to immediately discontinue any further reproduction of the Approved Forms and to fully cooperate with any request made by REBS and/or C.A.R. to return (or destroy at REBS and/or C.A.R.'s option) any materials, in whatever medium, containing the reproduced Approved Forms in your possession and/or reasonable control.
- 12. You/Company acknowledge that C.A.R. is the sole and exclusive owner of the Approved Forms. You/Company shall not represent directly or indirectly to any third party that You/Company have any proprietary rights in the Approved Forms. You/Company shall not, during or following the termination of your right to reproduce the Approved Forms, in any way dispute or impugn the validity of the Approved Forms or the rights of C.A.R. to the Approved Forms.
- 13. Within thirty (30) days of a written request by REBS, You/Company agree to provide to REBS, at Your/Company's sole cost, an accounting of any revenues and expenses associated with any product, service, course, book, or other item containing the Approved Forms.
- 14. You/Company agree to indemnify, defend and hold harmless REBS and C.A.R. and their respective officers, directors, employees, agents, and contractors from and against any and all claims, demands, actions, suits, damages, losses, deficiencies, costs and expenses, of any nature (including but not limited to reasonable attorneys' fees and expert witness fees) suffered as a result of any act or omission by You/Company or your respective employees, agents, contractors or affiliates related to the subject matter of these Terms and Conditions.
- 15. These Terms and Conditions shall be construed, interpreted, and enforced in all respects in accordance with the laws of the State of California, without regard to your actual state or country of residence and/or incorporation. You/Company hereby irrevocably consent to the jurisdiction of the state and federal courts of the County of Los Angeles, State of California in connections with any action arising under these Terms and Conditions.
